Ticks

Robbin Lindsay, Health Agency of Canada

From a historical perspective, tick-borne diseases in much of Canada including Ontario have been relatively rare and the scarcity of infection was primarily due to the limited range of some of the key tick vectors. However, in recent years the range of the blacklegged tick, *Ixodes scapularis*, an important vector of several diseases (e.g., Lyme disease, anaplasmosis and babesiosis), has expanded in a number of geographic areas in the province and risk of exposure to ticks and the pathogens that they transmit has increased, as a result. The objective of this presentation will be to provide an overview of the biology and ecology of ticks and tick-borne infections in Canada with special emphasis on those occurring in Ontario. A summary of the methodologies currently used to track the changes in tick distribution, and how this information is used to assess the overall risk of exposure to tick-borne pathogens will be provided. Finally, disease prevention and control strategies currently implemented to minimize the exposure of human and/or companion animals to infected ticks will be reviewed.
